Instructions

This template is intended for reporting a summary of Due Diligence pathways 2 "sector/fishery assessment" or 3 "ingredient manufacturer assessment" under Principle 2. Reporting is at a UAC level and on an annual basis.

The UAC should select the pathway used and the type of assessment (whether ingredient manufacturer or plant/main primary raw material).

The UAC enters the date the assessment was conducted.

The UAC selects the primary raw material assessed (if applicable). If primary raw material is not listed, the UAC enters the common name and latin name.

The UAC selects the risk factor assessed.

The UAC selects the country of location (ingredient manufacturer) or production (plant primary raw material). For marine primary raw material, "fishery" is selected as the Country of location.

The UAC selects the FAO fishing area for the marine primary raw material.
